Application type and application documents

ARTICLE 8-(1) Applications are made to OSTİM Technical University International Relations Office in person, online or by mail between the dates specified in the OSTİM Technical University Academic Calendar.

- (2) The documents required for application are as follows:
- (a) Application Form,
- (b) A notary certified Turkish translation of the High School Diploma or, for students who are at the graduation stage on the application date, of the educational status document to be obtained from their school,
- (c) An official transcript (transcript) approved by the high school directorate, showing the courses taken in high school and the grades of the candidate, and a copy of the Turkish translation approved by the notary public or Turkish Foreign Representatives,
- (d) For the candidates who have national or international exam result document approved by the University Senate, the copy thereof approved by the Turkish Foreign Representatives in the relevant country,
- (e) A copy of the pages of the passport comprising identity information and validity period and official Turkish translation thereof as approved by the notary public or Turkish Foreign Representatives in their country,
- (f) One passport size photograph.

Evaluation of applications

ARTICLE 9 – (1) Evaluation and acceptance of foreign students who apply are carried out within the periods determined in the academic calendar by an Evaluation Committee formed by the Senate. The university is free to fill or not announced quotas. Meeting the application conditions does not guarantee acceptance for placement. The exams valid for the application and minimum scores to be obtained from these exams are stated in the attached list. Applications of candidates who score below the minimum score determined in these exams and who do not meet other application requirements will not be evaluated. Evaluations are made within the framework of quotas, taking into account the exam scores of candidates, the overall grade point averages in the transcripts, letters of reference and intent, and the main and substitute candidates whose admission is deemed appropriate are determined. As a result of evaluation, other preferences of the candidate who is placed in one of her/his preferences as principal or substitute are not taken into consideration. Evaluation of applications made to OSTİM Technical University's programs that accept students with a special aptitude exam is made according to the criteria of the said special aptitude exam. The proposal prepared by the Evaluation Committee becomes final with the approval of the University Senate. An official acceptance letter is sent to the accepted students by the International Relations Coordinator so that they can get an "Education Annotated Visa".

Proficiency in Turkish language of the students placed in the programs conducted in Turkish language and English level of those placed in the programs conducted in English are determined according to the result of the language proficiency exam organized by the University or the results of a language test with national or international validity (TOEFL, IELTS, FCE, TOEIC, TÖMER, etc.). . Students who fail in language proficiency exam are taken to the Preparatory Class for one year. Students who are successful at the end of this period start the first year of programs they are registered. Those who fail are given an additional year. At the end of this period, the unsuccessful ones are unrolled from the University.

Fees

ARTICLE 11 - (1) Fees are determined each year by the Board of Trustees upon recommendation of the Board of Directors of the University. A student who does not pay tuition fee is not registered, or his /her registration is not renewed or frozen.

OSTIM TECHNICAL UNIVERSITY QUALIFICATIONS AND DOCUMENTS REQUIRED FOR APPLICATION

Exam types and base scores to be accepted in application

Applications made within the framework of this Directive are evaluated on the basis of the exams specified in the attached list. New exams and admission principles can be added to the exams specified in the Annex, with decision of the Senate and approval of the Council of Higher Education (YÖK).

Validity period of the exams in the status of university entrance exam (SAT, TCS, GAOKAO, Kazakhstan National University Exam, etc.) is 2 (two) years. There is no limitation on the validity periods of exams in the status of high school graduation exams (Abitur, International Baccalaureate, GCE, Tawjihi etc.).

Apart from the exams specified in the attached list, Foreign Student Exams conducted by other universities in Turkey are also accepted.
