SUMMARY OF THE DIRECTIVE FOR FOREIGN STUDENT ADMISSION

Quotas

ARTICLE 5- (1) Associate and undergraduate programs of our university that will accept foreign students and the quotas to be allocated to these programs are determined by Senate, approved by the Council of Higher Education, and announced with the relevant guide.

(2) The number of quotas allocated for admission of students from abroad are determined by the University Senate by department. The quotas of countries by department are included in the student admission announcement. In the event that there is no application for the quota allocated to countries and programs or the quota is not filled, the quotas that are not filled and not applied can be added to other program and/or country quota by the decision of Senate.

(3) In case the Senate decides to fill vacant quotas with additional placement due to no applications for the quotas and/or the non-registration of the placed candidates, the above provisions shall apply.

Students are accepted to the quotas determined by the University Senate as divided into countries with one or more of the national exams of the countries, international exams, the exam held by our University, the Foreign Student Exams made by the universities in Turkey, or the secondary education Diploma grade, the procedures and principles of which are also determined by the University Senate. There is no limitation on the validity period of the exams in the status of high school graduation exams, but validity period of exams in the status of university entrance exam is two years. Diploma grades or exam scores of candidates are converted into 100 (hundred) point grading system, where 100-point is accepted the highest grade, after which, those who have at least 85 (eighty-five) points of diploma grade or get at least 85 (eighty-five) points in these exams can apply for Undergraduate Programs of Faculty of Medicine and Faculty of Dentistry, while those having at least 50 (fifty) points of diploma grade or get at least 50 (fifty) points in these exams can apply for other undergraduate and associate degree programs. In additional placement, this success rate can be determined by the Senate as 30 (thirty) points or above, provided that the exam result is not unsuccessful. Candidates may be asked to graduate from a field and/or branch that is equivalent or close to the program they are applying for.

Evaluation and Placement

ARTICLE 8-

- (1) The evaluation, admission and placement procedures of the candidates applying for Trakya University foreign student admission quota are carried out by the "Foreign Student Admission, Evaluation and Placement Commission" formed by the Rector.

Fee and financial security

ARTICLE 9- (1) After the student contribution or tuition fee to be paid by the students to be accepted from abroad is determined by the Council of Ministers, it is decided by the Administrative Board of our University, provided that it remains within the minimum and maximum limits.

(2) In addition, in order to ensure that the financial means of students coming from abroad enable them to continue their higher education in our country, a financial security amount and/or form, the conditions and principles of which will be determined by our University, may be determined and the

candidate may be asked to provide this.

Disclosure of results

ARTICLE 10 - (1) Placement results are announced on the University's website.

Candidates who have the right to enroll in the university are sent an acceptance letter to the address specified in the Overseas Student Application Form.

Enrollment

ARTICLE 11- (1) Candidates placed and entitled to enroll as a result of the evaluation make final enrollment at the university in accordance with the principles and procedures in the text of announcement, acceptance letter or an equivalent document to be sent to them, enrollment dates and relevant legislation.

Enrollment application must be made with a passport with an education visa. Information about enrolled students is reported to the Council of Higher Education.

Language of education

ARTICLE 12 - (1) The language of education at our University is Turkish. The level of foreign language of students who are entitled to enroll in a department or program where compulsory Foreign Language Preparatory Class is foreseen is determined by the proficiency and placement exam.

QUALIFICATIONS AND DOCUMENTS REQUIRED FOR APPLICATION

Students are accepted to the quotas determined by the University Senate as divided into countries with one or more of the national exams of the countries, international exams, the exam held by our University, the Foreign Student Exams made by the universities in Turkey, or the secondary education Diploma grade, the procedures and principles of which are also determined by the University Senate.

There is no limitation on the validity period of the exams in the status of high school graduation exams, but validity period of exams in the status of university entrance exam is two years. Candidates' scores in these exams or Diploma grades are converted to the hundredth system, with the highest 100 (hundred) points accepted, and provided that the exam result is not unsuccessful,

- Those who have at least 85 points and above for the Faculty of Medicine and Faculty of Dentistry Undergraduate Programs,
- Those who have at least 50 (fifty) points or more for other undergraduate and associate degree programs,

or

- Those with a secondary education diploma grade of at least 85 and above for the Faculty of Medicine and Faculty of Dentistry Undergraduate Programs,
- Those with a secondary education diploma grade of at least 50 and above for other undergraduate and associate degree programs can apply.

In additional placement, this success rate can be determined by the Senate as 30 (thirty) points and above, provided that the exam result is not unsuccessful.

Candidates may be asked to graduate from a field and/or branch that is equivalent or close to the program they are applying for. One or more of the methods, exams and conditions and minimum scores determined in the table below are used in the admission of students from abroad.
