

GENERAL CONDITIONS FOR APPLICATION:

a) Applicants will be accepted on condition that they are in their final year of secondary school or have graduated:

1. For foreign nationals (provided that those studying in secondary schools in Turkey have enrolled before the academic year 2022-2023 [except for embassy schools, international private educational institutions included in the MOBİS system and foreign nationals brought to our country within the framework of the project implemented by the Ministry of National Education]).

2. Those who were Turkish citizens by birth, but who lost their Turkish citizenship by obtaining permission to renounce Turkish citizenship from the Ministry of Interior, and those who document that they have a blue card issued to those who lost Turkish citizenship upon request, (provided that those who study in secondary (high) schools in Turkey have enrolled before the academic year 2022-2023) 2023) (Article 7 of the Turkish Citizenship Law No. 5901 states that "(1) A child born in Turkey or abroad to a Turkish citizen mother or father within the framework of a matrimonial union is a Turkish citizen" and it is useful for the applicants who will apply for the admission quotas from abroad to examine the Turkish Citizenship Law).

3. Foreign nationals who have acquired Turkish citizenship with the citizenship acquired later / dual nationals in this situation, (provided that those studying in secondary education (high school) institutions in Turkey have enrolled before the 2022-2023 academic year)

4. Students of Turkish nationality who completed the last three years of their secondary education (high school) in a foreign country other than the TRNC (including those who completed their entire secondary education (high school) in Turkish schools opened by the Ministry of National Education in a foreign country other than the TRNC) who attended secondary education abroad before 01/02/2013)

5. Candidates who started secondary education abroad after 01/02/2013 and completed their entire secondary education (high school) in a foreign country other than the TRNC, (including those who completed their entire secondary education (high school) in Turkish schools opened under the auspices of the Ministry of National Education in a foreign country other than the TRNC)

6. TRNC nationals who reside in TRNC and completed their secondary education in TRNC and have GCE AL (The General Certificate of Education-Advanced Level) exam results, and those who have or will have GCE AL exam results by enrolling and studying in colleges and high schools in other countries between 2005-2010.

b) Candidates,

1) Turkish citizens who completed their secondary education (high school) in Turkey or TRNC,

2) Turkish Republic of Northern Cyprus nationals (except for those who have completed their entire secondary education (high school) in Turkish Republic of Northern Cyprus high schools and have GCE AL results and those who have or will have GCE AL exam results by enrolling and studying in colleges and high schools in other countries between 2005-2010),

3) Dual nationals whose first nationality is Turkish Republic by birth as defined in subparagraph 2 of Article A (except for those who meet the conditions in subparagraphs 4 and 5 of Article A)

4) Dual nationals, one of whose nationality is TRNC (except for those who have completed their entire secondary education (high school) in TRNC high schools and have GCE AL results and those who have or will have GCE AL exam results by enrolling and studying in colleges and high schools in other countries between 2005-2010),

5) Turkish nationals studying at schools under the embassies in Turkey and foreign high schools in Turkey or dual nationals whose first nationality is Turkish as defined in subparagraph 2 of Article A. ,

6) The applications of TRNC citizens and those who renounced Turkish citizenship/Blue Card holders and foreign nationals (except for embassy schools and international private education institutions included in the MOBİS system and foreign nationals brought to our country within the framework of the project carried out by the Ministry of National Education) who will enrol in secondary education institutions in Turkey as of the 2022-2023 academic year will not be accepted.

c) Any of the following examination results must be submitted at the time of application.

Candidates who have the minimum base scores from the exams above can apply for student quotas from abroad. Apart from these exams, exams approved by our University from higher education institutions in Turkey are also accepted.

In case of application with countries and exams not disclosed here, the scores determined by the International Student Admission Commission will be valid. Candidates who have received gold, silver and bronze medals from international science olympiads recognised by TÜBİTAK are not required to have a base score. Candidates who have obtained the minimum score required for making a preference in the score type of the relevant programme from the university entrance exams conducted by the Measurement, Selection and Placement Centre can apply to the programmes.
