

CONDITIONS OF ADMISSION OF FOREIGN STUDENTS AT THE UNIVERSITY OF BILECIK SEYH EDEBALI

Application

Explanations regarding the applications are announced on the website of our University http://www.bilecik.edu.tr in June every year.

Applications for admission of foreign students must be submitted to the coordination of the foreign students unit http://w3.bilecik.edu.tr/bilyos/ between the dates determined in July. No applications will be accepted except those made via the internet address.

Candidates with minimum base scores from the exams above can apply for student quotas from abroad. Apart from these exams, exams approved by our University from higher education institutions in Turkey are also accepted. In case of applying with exams from countries and exams not explained here, the scores determined by the Foreign Student Admission Commission will be valid. Candidates who have received gold, silver and bronze medals from international science Olympiads recognised and participated in by TUBITAK (The Scientific And Technological Research Council Of Türkiye) are not required to have a base score. Candidates who get the minimum score required to make a choice in the score type of the relevant programme from the university entrance exams conducted by the Measurement, Selection and Placement Center can also apply to the programmes.

Evaluation of Applications

Ensuring the coordination between the units, evaluating the applications for the announced quotas, conducting the placement procedures and resolving the objections to be made are carried out by the International Student Admission Commission and the placement process is finalised after the approval of the University Administrative Board. Meeting the application requirements is not sufficient for placement.

The applications of candidates who do not meet the application requirements are not evaluated. Candidates who do not register on the announced dates lose their registration rights. Instead of the candidates who do not register, registration is made among the reserve candidates on the specified dates. During the placement;

Firstly, candidates with BIL-YÖS (Foreign Students Selection Examination) score are placed. If the quotas are not filled, applicants with other exams are placed according to the point ranking and preferred programmes. If the quotas are not filled again, applicants with high school diploma are placed according to the point ranking and preferred programmes.

Evaluation is made on the basis of university and in general according to score and preference order.

The converted scores are ranked in descending order and the candidates are placed as full or alternate members according to the candidates' preferences and as long as they do not exceed the number of quotas determined by the department concerned.

As a result of the evaluation, the other preferences of the candidate who is placed in one of the preferences as the main or substitute are not taken into consideration.

In case of equality of the points taken as basis for placement, the younger candidate is preferred.

Language of Teaching

The language of teaching at our university is Turkish.

A1 Level (Basic-1)	0-30	The level of Turkish is not sufficient.
A2 Level (Basic-2)	31-45	The level of Turkish is not sufficient.
B1 Level (Intermediate-1)	46-60	The level of Turkish is not sufficient.
B2 Level (Intermediate 2)	61-75	The level of Turkish is sufficient.
C1 Level (Advanced-1)	76-90	The level of Turkish is sufficient

Candidates whose Turkish level is not sufficient will be subjected to one year of Turkish preparatory education. Candidates who raise their Turkish level to at least B2 level until the end of the year in which they will be considered to be on leave can start their education in the higher education institution. Turkish Proficiency Certificate is not required from those who graduated from secondary education institutions in Turkey and those who graduated from secondary education institutions abroad that provide Turkish education.

In order for the enrolment of the candidates who have the right to enrol, their Turkish language level must be sufficient. Those whose Turkish language level is insufficient are obliged to raise their Turkish language level to a sufficient level within one year. Candidates who cannot raise their Turkish language proficiency level to at least B2 within one year are given one more year by certifying that they have received TÖMER (Turkish and Foreign Languages Research and Application Center) education.

Candidates who are eligible to study in the university's affiliated units, but whose level of Turkish is not sufficient, must first take the Turkish course of TÖMER (Turkish and Foreign Language Research and Application Centre) at Bilecik Şeyh Edebali University. However, if deemed necessary and appropriate by the management of TÖMER, these candidates may attend a Turkish language course at another TÖMER, as instructed by the management. Students who go to another TÖMER for Turkish preparatory education without the advice of the TÖMER University management will be dismissed from the university.

Announcement of Results

Application results are announced on the website of our University. Candidates who have the right to enrol will be able to obtain their acceptance letters from the website of our University. Candidates are required to obtain a "Study Visa" by going to the Turkish Embassy in their country (or nearest) with this letter. This visa is absolutely necessary to enter Turkey and enrol at the university.

Registration

Registrations will be made by the units where the candidates are entitled to be a student.



Documents required for registration;

- a) The original of the "Certificate of Equivalence" to be obtained from the Ministry of National Education of the Republic of Turkey or the Turkish Embassy (Education Counsellor's Office) in their country showing that the high school diploma is equivalent to the diplomas obtained from Turkish high schools,
- b) The original high school diploma certified by the Turkish Embassy or Turkish Consulate in their country and the Turkish translation of the high school diploma certified by the Turkish Embassy or Turkish Consulate in their country or a notary public in Turkey,
- c) The original of the transcript certified by the Turkish Embassy or Turkish Consulate in their country and its Turkish translation certified by the Turkish Embassy or Turkish Consulate in their country or by a notary public in Turkey,
- ç) The original of the relevant exam result document and its Turkish translation certified by the Turkish Embassy or Turkish Consulate in their country or a notary public in Turkey (except for the BIL-YÖS exam result document and YÖS exam result documents of other Higher Education Institutions in Turkey accepted by our University),
- d) Turkish translation of the page of the official ID or passport showing the identity information, certified by the Turkish Embassy or Turkish Consulate in their country or a notary public in passport is written in Latin alphabet, Turkish translation is not required),
- e) Bank receipt showing that the tuition fee has been paid (The tuition fee is charged in the amount determined by the University and accepted by the Council of Higher Education, provided that it is within the minimum and maximum limits determined by the Council of Ministers every year),
- f) For citizens of countries that are not exempted from visa requirements by agreements to which the Republic of Turkey is a party or by the decision of the Council of Ministers, a "Study Visa" or a valid residence permit to be obtained from the Embassies/Consulates of the Republic of Turkey,
- g) For Blue Card holders, the original and photocopy of the Blue Card (Only the photocopy is received after seeing the original during registration),
- ğ) 1 passport size photograph,
- h) TÖMER Certificate,
- 1) For students with dual nationality, a copy of the Civil Registration Certificate (can be obtained from the civil registry offices),
- i) Financial security (This is a document showing that the candidate has the resources to cover his/her own living expenses. Students must provide for their own living expenses; the University does not provide scholarships or financial support to students from abroad and does not act as an intermediary in their provision)
