FOREIGN STUDENT APPLICATION AND ADMISSION CRITERIA

Quota

The quota and special conditions to be allocated for the admission of students from abroad to associate degree and undergraduate programs are determined by the Senate with the proposal of the Faculty/School/Vocational School and notified to the Presidency of YÖK (Higher Education Council of Turkey) by the Rectorate Registrar's Office.

The quota and application conditions determined for associate degree and undergraduate programs are announced on the website of YÖK and the Office of the Registrar.

If the quota allocated to any program remains empty, this quota can be transferred to Medicine and Law programs with the approval of YÖK and to other programs with the decision of the Senate. It is not necessary to fill all of the announced quota.

The quota of students to be admitted from abroad to the Faculties of Medicine and Dentistry cannot exceed 50% of the quotas of the programs that admit students by central examination in the previous year. There is no quota limit for other faculties/departments/programs. Quota can be allocated according to country/countries for international student admission. The quotas to be allocated for the country/countries are determined by the YOBÜ YÖS Commission and are included in the student admission announcement. If there is no application for the quota allocated to the country/countries or programs or if the quota is not filled, the quotas that are not filled and/or have no application can be transferred to other program and/or country quotas or country/countries quotas can be removed.

In order to increase the number and quality of students enrolling from abroad for the internationalization goal of the university, cooperation may be made with institutions and organizations that contribute to the promotion of the university and direct students who want to enroll in the university under conditions deemed appropriate by the Rectorate.

Announcement of results and registration

The results of the evaluation of the applications for associate and undergraduate programs and information about the registration procedures are announced on the University's website (www.bozok.edu.tr).

An acceptance letter is sent by the Rectorate to the candidates who are entitled to enroll in the University.

After the results are announced, the registration rights of the students who do not notify that they will come to the registration by sending a "confirmation letter" are canceled.

Registrations are made by the Rectorate Registrar's Office on the dates announced on the University web page.

The candidate, who is entitled to final registration, registers by applying to the Rectorate Office of the Registrar in person on the dates specified in the announcement. Registration cannot be made by mail or through someone other than the candidate. In place of the candidate who documents one of the excuses in the University Associate and Undergraduate Education and Examination Regulations, persons authorized with a power of attorney issued by the Foreign Representatives of the Republic of Turkey or notaries of the Republic of Turkey can register.

Applicant or incoming students apply to the International Student Support Office established within the university to exchange information on various issues.

Information about the enrolled students is reported to the Presidency of the Council of Higher Education.

Within one month after the registration process is completed, students enrolled in associate and undergraduate programs are required to apply to the Provincial Immigration Administration with the Residence Information Form for Foreign Students to be obtained from the Rectorate's Office of the Registrar.

Teaching

The language of instruction at the university is Turkish. Students enrolled in programs whose medium of instruction is Turkish or fully/partially in a foreign language start their undergraduate education according to the results of the Turkish Language Proficiency (Diploma) or placement exams (Placement Exam / Exemption Exam at the beginning of the year) conducted by BOZOK TÖMER Directorate. It is compulsory for each enrolled candidate to take this exam. If the equivalence and approval procedures of the candidates with C1 Turkish Proficiency certificate are carried out by BOZOK TÖMER Directorate, the obligation to take the exam is eliminated.

For those who do not have Turkish language proficiency, one-year Turkish education is provided by the Directorate of Turkish Language Teaching Research and Application Center (BOZOK TÖMER). Students who are not successful in the exams they take as a result of this training are dismissed from our University.
