STUDENTS WHO HAVE / DON'T HAVE THE RIGHT TO MAKE APPLICATION

Article 1- Those who can make application

Applications of candidates who have following qualifications and who are in the last year of or have graduated from high school or equivalent schools are accepted:

a) Those who are citizen of a foreign state;

b) Those who are Turkish citizens by birth, have obtained permission to renounce Turkish citizenship from the Ministry of Internal Affairs for themselves and their minor children, and are able to certify both themselves and their children, if they are subject to Article 7 of the Law No. 5901 on the Turkish Citizenship;

c) Those who have taken Turkish citizenship from citizenship of another country / dual citizens in this situation;

c) Those who have completed the last three years of secondary education (high school) in a foreign country other than TRNC among the Turkish citizens who have continued their secondary education abroad before 01/02/2013 (including those who have completed whole secondary education (high school) in Turkish schools opened under surveillance of TR MoE at abroad); those who have completed all of secondary education (high school) in a foreign country other than TRNC among the Turkish citizens who have begun their secondary education abroad before 01/02/2013 (including those who have completed whole secondary education (high school) in Turkish school) in a foreign country other than TRNC among the Turkish citizens who have begun their secondary education abroad before 01/02/2013 (including those who have completed whole secondary education (high school) in Turkish schools opened under surveillance of TR MoE at abroad);

d) TRNC citizens who reside in the TRNC and have completed their secondary education (high school) in the TRNC and have GCE AL exam results, and those who have continued education in colleges and high schools in other countries between the years 2005-2010 and have or will have GCE AL exam results.

Article 2- Those who don't have the right to make application

Applications of candidates whom situations are specified below are not accepted:

a) TR citizens who completed their whole secondary education (high school) in TR or TRNC,

b) TRNC citizens (except those who completed their secondary education (high school) in the TRNC and have GCE AL exam results, and those who have continued education in colleges and high schools in other countries between the years 2005-2010 and have or will have GCE AL exam results);

c) Dual citizens who are originally TR citizen by birth as defined in the Paragraph (b) of Article 1 (other than those who meet the conditions set forth in the Paragraph (ç) of Article 1),

ç) Dual citizens one of whom citizenships is TRNC (except those who completed their secondary education (high school) in the TRNC and have GCE AL exam results, and those who have continued education in colleges and high schools in other countries between the years 2005-2010 and have or will have GCE AL exam results);

d) Those who study in schools under the embassies in Turkey and foreign high schools in Turkey, who are Turkish citizen or whom first citizenship is TR by birth according to Article 1, Paragraph (b).
