SUMMARY OF DIRECTIVE FOR SELECTION AND PLACEMENT OF OVERSEAS STUDENTS IN GRADUATE AND UNDERGRADUATE PROGRAMS

Exam for Foreign National Students or Students from Abroad

ARTICLE 5- (1) SBUYOS is held once a year. Application dates for the exam, the way the exam is conducted, its content and date are specified in the Guide accepted by the Senate.

- (2) SBÜYÖS is administered by the Health Sciences University International Student Coordinator, authorized by the Rector.
- (3) The coordination of exam and the announcement of results are carried out in line with the decisions and instructions of the coordinator.
- (4) Application, exam and tuition fees are determined by the SBU Executive Board and announced on the University's website.
- (5) SBÜYÖS result is valid for one (1) academic year following the exam date.

Program preference conditions

ARTICLE 9- (1) Candidates who get the base points determined by the coordinator for each program in the SBÜYÖS exam can apply to the quota for foreign students or students from abroad. Base scores are specified in the guide.

- (2) Necessary information for preferences and special conditions and explanations, if any, are announced on the University's website.
- (3) Candidates can apply to a maximum of 3 (three) diploma programs. Applications to these programs are made online at https://basvuru.sbu.edu.tr.

Evaluation and Placement

- ARTICLE 11- (1) The candidate is placed in only one program according to the result of his/her preference. However, in line with the principles to be determined by the Senate, education can be taken in a second major, too.
- (2) Placement of candidates in the quotas is made in accordance with their score in the exams conducted by SBUYOS or other internationally recognized institutions, in the order of their preference and the number of candidates from the same country admitted to a program. The number of candidates entitled to enroll from the same country cannot exceed 20% of the total quota of relevant program. In case of equality in placement in the quotas, priority is given to the younger students. In case of the continuation of equality, the priority is determined by alphabetical order of the first letters of names and surnames of candidates. In case the quota is not filled, the University may take action by considering the number of countries and other relevant issues.
- (3) Specially for Medicine and Dentistry programs included in the foreign student admission quotas determined by the Council of Higher Education; 10% of quota in the aforementioned fields will not be exceeded for candidates who have the opportunity to apply for the quota for student admission from

abroad, those who have a blue card, those who are Turkish citizens who have completed their high school education abroad (except for the TRNC), and those who have dual citizenship, one of which is the Republic of Turkey, as per the Principles Regarding the Admission of Students from Abroad.

Language of Education

ARTICLE 14- (1) The language of education at the University is Turkish and/or English, according to the language of education of the program applied for.

Announcement of Results and Enrollment

ARTICLE 12-

- (1) The results of evaluation of applications and placement of candidates in the programs are announced at candidate application system, which can be accessed at https://basvuru.sbu.edu.tr. Candidates who have the right to enroll in the university can access their acceptance letters through the application system. Candidates are required to go to the Turkish Foreign Representative Office together with their acceptance letter and obtain an "Education Visa".
- (6) Applications of those who make false statements, submit falsified, forged, incomplete and incorrect documents during the application, placement and enrollment process are rejected. If these candidates are enrolled in the programs they applied for, their enrollment will be canceled. Necessary legal actions are taken against those whose actions and transactions constitute a crime.

UNIVERSITY OF HEALTH SCIENCES QUALIFICATIONS AND DOCUMENTS REQUIRED FOR APPLICATION

Application

Exam for Foreign National Students or Students from Abroad

SBUYOS is held once a year. Application dates for the exam, the way the exam is conducted, its content and date are specified in the Guide accepted by the Senate.

SBUYOS is run by the Health Sciences University International Student Coordinator, authorized by the Rector.

The coordination of exam and announcement of results are carried out in line with the decisions and instructions of the coordinator.

Application, exam and tuition fees are determined by the SBU Executive Board and announced on the University's website.

SBÜYÖS result is valid for one (1) academic year following the exam date.

Selection and Evaluation Process for Foreign Students

Health Sciences University International Student Coordinatorship is authorized by SBU every year for all necessary arrangements to make the selection and evaluation procedures regarding the admission of foreign students students as associate or undergraduate students. The related processes such as whether an exam will be held regarding student selection, national and/or international exam results to be accepted if the exam is not held, secondary school success and diploma grades, the way of selecting students, the place, time, procedures and principles regarding the exam and/or interview when necessary are determined by the coordinatorship and announced on the University's website. Student selection and evaluation processes are also carried out in centers abroad determined according to the international agreements of our university,

Objections to the exam and placement results made by the Coordinatorship can be made within 5 (five) working days from the announcement of the results. Objections are examined by the coordinator and the final decision is made.

Evaluation and Placement

The candidate is placed in only one program according to the result of his/her preference. However, in line with the principles to be determined by the Senate, education can be taken in a second major, too. Placement of candidates in the quotas is made in accordance with their score in the exams conducted by SBUYOS or other internationally recognized institutions, in the order of their preference and the number of candidates from the same country admitted to a program. The number of candidates entitled to enroll from the same country cannot exceed 20% of the total quota of relevant program. In case of equality in placement in the quotas, priority is given to the younger students. In case of the

continuation of equality, the priority is determined by alphabetical order of the first letters of names and surnames of candidates. In case the quota is not filled, the University may take action by considering the number of countries and other relevant issues.

Specially for Medicine and Dentistry programs included in the foreign student admission quotas determined by the Council of Higher Education; 10% of quota in the aforementioned fields will not be exceeded for candidates who have the opportunity to apply for the quota for student admission from abroad, those who have a blue card, those who are Turkish citizens who have completed their high school education abroad (except for the TRNC), and those who have dual citizenship, one of which is the Republic of Turkey, as per the Principles Regarding the Admission of Students from Abroad.

Meeting the application conditions does not entitle the right of placement in the program.

Applications of candidates who are determined not to meet the application conditions will not be evaluated.
