FOREIGN STUDENT APPLICATION CONDITIONS

Students are accepted to the quotas determined and announced by the University Senate in accordance with the principles and procedures to be determined by the University Senate and taking into national exams of their countries, international exams, the exams held by our University, the Foreign Student Exams made by the universities in Turkey, and their secondary education Diploma grades. There is no limitation on the validity period of the exams in the status of high school graduation exams, but validity period of exams in the status of university entrance exam is two years. Candidates' scores in these exams or Diploma grades are converted to the hundredth system, according to which the highest grade is 100 (hundred) points. Those who have a score of at least 60 (sixty) points and above can apply. This success rate can be changed by the Senate in additional placement. Candidates may be asked to graduate from a field and/or branch that is equivalent or close to the program they are applying for.

Evaluation and Placement

Evaluation, acceptance and placement procedures of the candidates applying to Bandırma Onyedi Eylül University's foreign student quota are carried out by the

"Committee on Foreign Student Admission, Evaluation and Placement" formed by the Rector.

The scores that the candidates obtained from national exams of their countries, the international exams, the exam held by our University, the Foreign Student Exams carried out by the universities in Turkey, and their high school diploma grades are converted to the hundredth system in accordance with calculation method given in the Table 2. The placement process is carried out by taking into account the scores and preferences of the students. In case of equality, the younger student, then the student who has just graduated from secondary education is preferred; in the event of the last tie, the candidate is determined by lot.

The evaluation and placement procedures of the candidates who apply to the programs that accept students with a special talent exam are carried out in accordance with the principles and procedures of these programs.

Applications of candidates who are determined not to meet the application conditions will not be taken into evaluation.

Disclosure of results

Placement results are announced on the University's website. No further notification is made to the candidates who gain the right to enroll in the university. Upon the request of the candidates, a Letter of Acceptance is issued.

Enrollment

Candidates who are placed and entitled to enroll as a result of the evaluation make final registration to the university within the framework of the principles and procedures in the announcement text. Enrollment application must be made with a passport with an education visa. Information about enrolled students is reported to the Council of Higher Education.

Language of education

The language of education at our University is Turkish. The level of foreign language of students who are entitled to enroll in a department or program where compulsory Foreign Language Preparatory Class is foreseen is determined by the proficiency and placement exam.

Proficiency level in Turkish

Evaluation of Proficiency in Turkish

a) (C1 and C2) Level: Proficiency in Turkish is sufficient. The enrollment is made in the program for which the enrollment is granted.

b) (B1 and B2) Level: Turkish level is not sufficient, but it can be improved. Provided that s/he takes a Turkish course, s/he enrolls in the program for which s/he gains the right to enroll. The student must document that s/he has increased his/her Turkish level to (C1-C2) level by the beginning of the third academic year at the latest. At the end of this period, those whose Turkish is still at (B1-B2) level cannot continue their education and training until they increase their language level to (C1-C2).

c) (A1 and A2) Level: Proficiency in Turkish is insufficient. S/he should take a Turkish course. In this case the candidate must document that s/he has increased her/his Turkish level to (C1-C2) level by the beginning of the third academic year at the latest. The first clause of this paragraph is applied to those who increase their Turkish proficiency level to (C1-C2) level, and the second clause of this paragraph is applied to those who raise their level of proficiency to (B1-B2).

Students enrolled in programs where the language of instruction is Turkish must be successful in the Turkish exam conducted by the language centers of universities or other Official Institutions. Those who are unsuccessful must attend a Turkish language course of maximum one year opened by the language centers of the universities or other Official Institutions and be successful in the Turkish exam by getting at least B1 level according to the criteria of the European Union Language Portfolio (European Language Passport). Those who are not successful at the end of one year will be considered on leave for 1 more year.

Students who do not develop their Turkish to at least C1 level within the given period lose their right to study at the higher education institution they are registered to.
